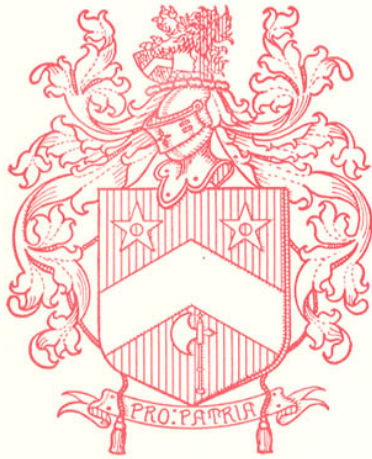

**The applicant hereby applies for membership in the Society in right of lineal descent from Mareen Duvall, a Huguenot Refugee, who settled about the year 1655 in the Province of Maryland where he died in August 1694.**

Mareen Duvall was born about 1625 in the Kingdom of France and settled on the south side of the South River in Anne Arundel County, Province of Maryland. The first tract of land patented to him in 1659 by Lord Baltimore was called "Laval," the name of an ancient town, the capital of the present Department of Mayenne. He was a planter and merchant, and a public spirited citizen of the Province until his death. He resided at the time of his death on his plantation, located on South River, patented to him in 1664 by the Lord Proprietary, by the name of "Middle Plantation." His public services consisted in part, as shown by Provincial Archives, leadership in the Jacobite party, and membership in the Provincial Commission, appointed in 1683 by the Proprietary and Assembly, to lay out town sites and ports of entry for the encouragement of trade. He was the patentee of numerous tracts of land, and the purchaser of many others containing several thousand acres, as evidenced by the Public Land Records and his Will dated, and probated in August, 1694.
